## Reasons to Submit a Poster Abstract

- **Visibility** - Your name will be featured in the Conference Programme, as well as in the event's mobile App.
- **Opportunity for oral presentation** - Authors of outstanding poster abstracts will have the opportunity to present their work during the dedicated poster session.
- **Be Creative** - Submission allows you to be creative in visually sharing your presentation as ePoster.
- **Boost your CV** - Presenting your research at an international conference is an added value to your CV as it helps you to stand out among other candidates and as a recognized expert.
- **Networking** - Discuss your findings with other experts from around the world. More than 2'000 attendees will be present at DIA Europe 2021 from approximately 60 countries. Meet with your fellow colleagues who are interested in the same topics.
- **Sharing is caring** - Sharing your research helps to advance healthcare all around the globe.
- **Opportunity for open publication** - All accepted poster presenters will have the opportunity to sign up for open publication. The posters are going to be made available on different platforms, such as Google Scholar.

## General Submission Requirements

(Please read the following instructions carefully, as incorrect or incomplete abstracts will not be considered.)

- All abstracts must be submitted online at [DIAGlobal.org/Abstracts](https://diaglobal.org/Abstracts).
- The title must reflect the abstract content accurately and concisely.
- All poster presentations must be non-commercial and scientific in nature and cannot be used as a marketing opportunity. Any mention of specific products or and/or services must be limited to generic names, with no inclusion of brand names in any area of the poster, including poster titles and/or handouts. Logos and advertising may not appear anywhere on the poster.
- Posters must be original in research and include appropriate empirical evidence.
- Posters must include data (e.g. methodology, research results, conclusion, etc.). Preliminary/pilot data is acceptable.
- Only one author is to be identified at the time of submitting.
- Each author can have only one poster accepted. If more abstracts are submitted, the organising committee will consider all abstracts and select the most relevant one for Poster display).
- All accepted poster authors must be registered for DIA Europe 2021.

## Guidelines

You can plan your abstract submission in advance by preparing following information below, required for your online submission.

- **Abstract Title** - Maximum 125 characters including spaces. Titles should briefly describe the focus of the poster as well as accurately reflect its content.
- **Interest Area/Track** - Select the interest area that best suits your poster's subject/topic.
- **Keywords** - Maximum 100 characters including spaces. Please provide 1 or more keywords associated with your poster abstract. These may be used for search purposes should your abstract be selected. Examples of keywords: Personalised Medicine, Health Technology Assessment, Clinical Trial Agreements, Harmonisation, Patient Engagement.

## Abstract Structure

- **Objective** - Maximum 300 characters including spaces. Add a statement (preferably, one sentence) on the objective of the abstract.
- **Method** - Maximum 300 characters including spaces. When, where, and how was the study was done? What materials were used or who was included in the study?
- **Results** - Maximum 2000 characters including spaces. What quantitative data was collected; what answer was found to the research question; what did the study find? Was the tested hypothesis true?
- **Conclusion** - Maximum 2000 characters including spaces. State what can be concluded from the study and its implications.










## Acceptance Requirements

- If an abstract is accepted, the primary author/presenter is required to pay the applicable meeting registration fee and related expenses, and must be onsite at DIA Europe 2021, in Basel, during the designated Poster Session time. Exhibitors are required to pay the full exhibitor upgrade.
- Please note that an author may not represent more than one Poster.
- Co-authors who would like to be present must register by the deadline. If none of the authors are able to attend the meeting, the poster will be withdrawn from the programme.

## Poster Presentation and Display

- **Oral Poster Presentations**  
Selected poster authors will have the opportunity to present their work in oral presentation format, in addition to displaying their poster onsite. Additional information regarding oral poster presentations will be given upon acceptance of the poster.
- **e-Posters**  
All accepted posters will be displayed electronically at the conference. Presenters will provide DIA with an electronic file of their poster.
- **Specs:**  
File Format: PDF (.pdf);  
Orientation: Landscape format only, single-page,  
Dimensions: 1536 width x 1080 height pixel or 54,2cm width x 38,1cm height  
Recommended font size: Minimum 16 points  
Maximum file size: 40 MB
- **Recorded Poster Presentation**  
Besides the ePoster all accepted poster presenters will be required to submit their 5 minutes pre-recorded poster presentation.
